

# **GINO'S PIZZA® ELECTRIC MUSTANG PROMOTION (Promotional Rules)**

## **CONTEST PERIOD**

Gino's Pizza® Electric Mustang Promotion (the "Promotion") commences during Gino's Pizza® operating hours at **12:00:01am Eastern Time (ET) on Monday, May 15, 2023 and ends at 11:59:00pm ET on Sunday, November 26, 2023** (the "Contest Period"). This contest is brought to you by Gino's Pizza® ("Contest Sponsor"). The Contest Period may be amended – either shortened or lengthened - at the sole discretion of Contest Sponsor without prior notice.

## **HOW TO ENTER**

1. During the contest period, Forty (40) 'Pre-qualifiers' will be randomly selected for a chance to win a Ford (2024) Mustang Mach-E SELECT. An event will be held on Thursday December 7<sup>th</sup>, 2023 at a Ford dealership in Mississauga (selected by Contest Sponsor) where each 'Pre-qualifier' will randomly select a sealed envelope. The 'Pre-qualifier' who selects the winning envelope will become the winner of the Electric Mustang.
2. 'Pre-qualifiers' are randomly selected in one of two ways: **a)** Place any online order containing wings (regular or breaded or boneless) OR drinks (minimum 2) and you are automatically entered for a chance to prequalify. One 'Pre-qualifier' will be randomly selected each week from the previous week's orders. Weekly orders begin at the start of business on Monday and ends on Sunday at the close of business. **b)** At a special events location, fill out the back of your receipt with your full name, phone number, and email address and deposit it into the on-site ballot box between the hours of 11:00am and 8:00pm. ## **ODDS**

3. Odds of pre-qualifying when ordering on-line will be based on the number of qualifying on-line orders received for the week. Odds of pre-qualifying at the special events will be based on the number of ballots deposited into the ballot box on the special events day. The odds of winning after pre-qualifying are 1 in 40 if all 'Pre-qualifiers' are present.

## **GENERAL**

4. No less than six (6) separate attempts will be made to contact 'Pre-qualifiers'. Three (3) attempts by phone and three (3) attempts by email. If a 'Pre-qualifier' is unreachable by the contest closing date, then that 'Pre-qualifier' will be omitted from the contest and the odds for the remaining 'Pre-qualifiers' will increase.
5. To be notified on the date and address of special events, you can sign up for Gino's Pizza® E-blast. Gino's Pizza® will not be responsible if weekly E-Blasts are not received. If you have signed up and are not receiving the E-blast, please contact Gino's Pizza® headquarters during regular business hours.
6. Duplicate receipt or receipts obtained without purchase or through other means will not be counted. We reserve the right to limit the number of receipts per customer per special event. Only those receipts that were obtained on the special events day and location will count in the random draw.

7. Prior to the final random draw, each 'Pre-qualifier' must first correctly answer (without assistance or mathematical aid), the mathematical skill-testing question available at the event held on Thursday December 7<sup>th</sup>, 2023 and agree to comply with the rules of this contest.
